The purpose of the conference is to exchange the opinions of scientists regarding the prerequisites and causes of the Russian-Ukrainian war, research and discussion of topical issues of protecting the state sovereignty and territorial integrity of Ukraine, maintaining social and political stability, ensuring the rights and freedoms of citizens.

The conference is scheduled in the following sections:

1. National identity and civil patriotism in the conditions of war
2. The constitutional mechanism of the protection of civil rights in conditions of military aggression
3. Peculiarities of functioning of public authorities in extreme conditions

Working languages of the conference are Ukrainian, Polish and English.

The text is submitted in the author's edition. The author is responsible for the accuracy of the information provided.

Deadline for submission of materials is **September 12, 2022.**

Format: remote

Participation fee is 200 UAH

Conference proceedings. Each participant of the conference will have access to the electronic version of the conference proceedings, which will be posted on the website of the Department of Theory of Law and Constitutionalism of the Lviv Polytechnic National University.

- 2) abstracts of the report;
- 3) confirmation of payment.

Requirements for conference papers

➤ Materials should be submitted as a .doc attachment to the e-mail address oksana.i.fedoriv@lpnu.ua.

➤ Papers should not exceed 5 pages (scope is 3-5 pages). Formatted in Word, font *Times New Roman* 14 pt., 1,5 spaced, all margins 20 mm, paragraph spacing 10 mm, paper size A4. The pages are not numbered.

➤ In-text references are included with square brackets, where the first digit is the ordinal number of the source in the reference list, and the second one after the comma is a number of the page. A reference list is to be

included at the end of the paper in alphabetical order.

➤ On the first page please indicate:

- 1) name, surname of the author (s), academic degree, academic title, position and place of work at the top on the right;
- 2) the title of the paper spaced, in bold, center aligned, all capitals;
- 3) text spaced.
